**BUSINESS:** Spring Road School 2024 – C Warner reported that he and T Conaway will be attending the 2004 Spring Road

<u>Scot Kelly – Northwood School Update</u> – Scot Kelly gave an update on what is happening at the school. They currently have the highest enrollment in the last 6 years. They are building a bus shelter. He also gave an update on the Community Focus Group meet 3 times, a facilities update, a finance update and a survey they

are putting together.

Minong Area Disposal Equipment – The state inspector showed up at the transfer station because the transfer station had been turned in for incorrect weights and being charged to much. The inspector found that our scale was correct however he wrote the transfer station up for multiple infractions with 2 weeks to repair. We are purchasing a new scale and there is some cement work that needs to be done in the pit. Since

we were able to show proof that we are working on the infractions, we have until May 31<sup>st</sup> to get everything completed. Otherwise we would have been shut down. The transfer station will need to be shut down for approximately 3 days.

<u>Gracie Lane Road – Possible Road Abandonment - Hearing Date</u> – Letters have been sent to the individuals whose land adjoins the road. Hearing Date was set for May 1st at 6:00 pm at the Town Hall.

<u>2024-2026 Road Plan</u> – C Warner, C Holland, B Henning and T Conaway went out and looked at the roads that were currently on the 2024 plan and then looked at additional roads for the 2025 & 2026.
